

MANUFACTURING SECTOR

Manufacturing companies operate in a highly competitive global marketplace. This sector includes companies that transform materials into new products using machines, tools, high-tech activities and manual tasks. Segments within the manufacturing sector include aircraft, satellites, defense systems, automobiles, appliances, building materials, personal care products, children's products, apparel, chemicals, computers and electronic goods.

According to the U.S. National Association of Manufacturers, the United States makes up over one-fifth of the world's manufacturing industry, followed by China and Japan. In 2015 alone, manufacturing in the U.S. accounted for \$1.5 trillion, or approximately 11% of the nation's GDP.

Manufacturing companies face a number of complex challenges ranging from domestic and foreign competition to escalating labor and production costs. The international community is increasingly aware of the harmful impacts of-processes, and resulting processing wastes, have on the environment. Governments in these nations are implementing stricter rules and standards governing operations. This increased regulatory oversight can drive manufacturing costs up dramatically. The U.S. National Association of Manufacturers reports that regulatory compliance costs manufacturing companies an estimated \$180.5 billion each year.

Environmental Laws and Regulations Impacting the Manufacturing Sector

Environmental laws and regulations place a tremendous burden on companies operating throughout the manufacturing sector. Over the last two decades, regulatory oversight has been expanding both nationally and internationally resulting in increased expenses for companies operating in this sector.

A myriad of complex environmental laws govern the activities of companies in the manufacturing sector. The U.S. Environmental Protection Agency (EPA), the Department of Agriculture (USDA), the

Department of Health and Human Services (HHS), the Department of Energy (DOE) and many other federal and state governmental bodies share responsibility for setting and enforcing rules and standards designed to protect the health of the environment and the public. Federal and state statutes such as the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), the Resource Conservation and Recovery Act (RCRA), the Clean Air Act, the Clean Water Act, the Toxic Substances Control Act (TSCA), CEQA and NEPA are just a few of the environmental laws governing manufacturing operations. These laws create significant costs for companies which are pervasive throughout the design, supply chain, marketing, sales, distribution and end-of-life of the product.
